* I acknowledge that the activities provided by Sliders are not available to pregnant women and that by accepting these terms I confirm that the participant(s) is/are not pregnant.

I agree and promise to ensure the participant(s) accept(s) to be responsible for any and all risks existing and subsisting in the activities. I acknowledge that participation in the activities is voluntary and that the participant(s) elect(s) to participate despite of the risks and agrees to accept the consequences of so doing. In the event of an injury or accident, I authorize Sliders to provide first aid and if necessary I will be transferred to the local hospital.
