* I acknowledge that the activities provided by Sliders are not available to pregnant women and that by accepting these terms I confirm that the participant(s) is/are not pregnant.

I agree and promise to ensure the participant(s) accept(s) to be responsible for any and all risks existing and subsisting in the activities. - * I and as parent or legal guardian of any accompanying children give consent and agree to Sliders photographing and/or recording(s) myself and any accompanying children and to use any such photographs and/or recording solely and only for Sliders advertising and promotional purposes.
