* I acknowledge that the activities provided by Sliders are not available to pregnant women and that by accepting these terms I confirm that the participant(s) is/are not pregnant.

I agree and promise to ensure the participant(s) accept(s) to be responsible for any and all risks existing and subsisting in the activities. I acknowledge that participation in the activities is voluntary and that the participant(s) elect(s) to participate despite of the risks and agrees to accept the consequences of so doing. In the event of an injury or accident, I authorize Sliders to provide first aid and if necessary I will be transferred to the local hospital. - * I and as parent or legal guardian of any accompanying children give consent and agree to Sliders photographing and/or recording(s) myself and any accompanying children and to use any such photographs and/or recording solely and only for Sliders advertising and promotional purposes.
