* That the participant(s) will not use Sliders's facilities and activities whilst under the influence of any drugs or alcohol.

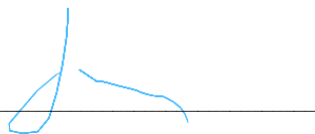
