

Europe - Friendship - Salt Room – Training

Before visiting the **EUROPE SALTY ROOM** located in the Europa Sports Center, in short - the "Center", I have familiarized myself with the Safety Instructions and Rules for using the salt room located in the Center, including the instructions of the staff of the Center, as well as with the introduced Anti-epidemic measures on the territory of the Center and I will comply with the below rules, instructions and measures while I am on the territory of the Center.

When using and using the equipment in the Center, you will take into account your physical and health condition. When visiting and using the facility at the Center, I will take into account my physical and health condition. I declare that I do not suffer from a high temperature (above +37 °C). I am not sick and have never had tuberculosis; I am not Onco sick and I am not in remission; I do not suffer from cardiovascular diseases, I do not suffer from high blood pressure, which is normally maintained with medication. I understand that my use of the facility at the Sports Center involves certain risks, including the risk of serious ill health or even fatal consequences as a result of neglecting my health. The mentioned risks depend on many factors, incl. age, physical condition, medical recommendation to refrain from such procedures or drug contraindication reactions. Proceeding to use the salt room in the Center by me, I declare that I am aware of the risks, and release **"Steneto" EOOD and "New Power" EOOD**, as managers of the Center, its employees, directors, grantors, successors, sales representatives, subsidiaries and related persons from responsibility for the occurrence of the risks described in item 3 related to me, when the same occur as a result of incorrect decisions on my part in relation to use of the facilities, equipment or misjudgment of my physical condition, the responsibility for my life and health while visiting being entirely mine.

By starting to use the facilities in the Sports Center, I release **"Steneto" EOOD and "New Power" EOOD**, as managers of the Sports Center, its employees, directors, licensors, successors in title, sales representatives, subsidiaries and related persons from liability for the occurrence of those described in item 3 risks related to me, when they occur as a result of incorrect decisions on my part in connection with the use of the facilities, equipment or

incorrect assessment of my physical condition. I am informed that when I visit the Sports Center, **"Steneto" EOOD and "New Power" EOOD** and their employees, including the instructors and receptionists at the Sports Center, do not monitor and do not take responsibility for my actions, such as the responsibility for life and my health when visiting is all mine.

I understand that visiting the Sports Center and/or using the facilities at the Sports Center is associated with the risk of contracting infectious diseases and/or transmitting infectious diseases, including, but not limited to, Covid-19, viral hepatitis, influenza, acute respiratory diseases, etc., for which risks **"Steneto" EOOD and "New Power" EOOD**, as managers of the Sports Center, its employees, directors, grantors, successors, sales representatives, subsidiaries and related persons do not assume responsibility.

After the safety measures have been explained to me in detail and in an accessible language, according to the RZI regulations that will be applied, I agree personally, on my own behalf, to participate and/or observe the activities offered at the Sports Center.

STATEMENTS REGARDING THE PROCESSING OF PERSONAL DATA BY SPORT CENTER EUROPE

I am informed that **"Steneto" EOOD and "New Power" EOOD** are controllers of personal data, within the meaning of the Personal Data Protection Act and Regulation (EU) 2016/679 of the European Parliament and of Council and processes my personal data.

I agree to have my temperature measured at the entrance to the Center in connection with compliance with the introduced anti-epidemic measures on the territory of the Center.

I am familiar with the Policies of **"Steneto" EOOD and "New Power" EOOD** for the processing and protection of personal data, and in this regard I give my consent to my personal data being processed for the purposes, in the manner and for the period, expressly stated in her.

I am informed that video surveillance is carried out on the territory of the center for the purpose of prevention and security of visitors and observers, and I give my consent for my personal data to be processed in this way for the purposes, in the manner and for the period expressly stated in the Privacy Policy.

I am informed that **"Steneto" EOOD and "New Power" EOOD** are not responsible for any damages or losses incurred, including theft, lost or damaged personal belongings during my stay on the territory of the center, and I take personal responsibility to observe the security of the property mi.

In view of the above, I declare that I have been informed and agree with the general conditions.

RULES FOR THE INTERNAL ORDER:

Only adults who have declared that they are aware of the risks arising from visiting the Center are admitted to the sports center.

If the visitor is a minor, the declaration must be signed by a parent/guardian/adult entrusted with the care of the minor.

Persons under the age of 14 may only use the facilities within the framework of organized training and courses or if they are accompanied by their parents, guardians or coaches with established sports experience.

Visitors to the Center can use individual rooms independently only if they have the appropriate experience.

No intoxicants and alcohol, as well as drinks and food, can be brought into the Center.

Visitors are responsible for protecting their belongings and valuables.

The sports center offers equipment, appliances and furniture. It is not allowed to take this stuff out of the hall.

Customers who use their own equipment in the hall are responsible for its reliability and compliance with applicable standards.

The clients of "**SPORT CENTER EUROPE**" can use the halls and facilities only with clean sports shoes.

Smoking on the site is prohibited.

Center employees have the right to remove any visitor to the Center if their behavior poses a risk to them and others.

Hall staff may require compliance with additional rules to ensure safety.

"**SPORT CENTER EUROPE**" is not responsible for lost or stolen items and valuables.
