Proceeding to the use of the facilities in the Centers by me, independently and without a instructor, I declare that I have passed a training course provided by a qualified instructor, and release Collider Climbing EOOD., as manager of the Centers, its employees, directors, shareholders, legal predecessors, successors, sales representatives, subsidiaries and related parties from liability for the occurrence of the risks described in item 3 related to me when they occur as a result of unsound decisions on my part in connection with the use of the facilities, equipment or incorrect assessment of my physical abilities.
